Rates as quoted are subject to availability, and are valid from 01/04/10 to 31/03/11. By using the above rates you agree with and abide by our Terms and Conditions. Rates quoted are per room per night on a room only basis. All rates are inclusive of GST and quoted in AUD. Rates may increase without notice due to any changes in or the imposition of government charges taxes or levies. All rooms are non-smoking.

Check In/Check Out: Check in time is from 2.00pm and check out is 10.00am. Additional charges apply to guarantee early arrival and late departure

Cancellation Policy:

Low Season & Special Season:

For bookings cancelled within 8 days of travel or no-show, no refund will apply.

Mid season:

For bookings cancelled within 15 days of travel or no-show, no refund will apply.

High season:

For bookings cancelled within 25 days of travel or no-show, no refund will apply.

Last minute bookings:

For reservations received within the cancellation policy period, the booking will be held for 48 hours, should the booking cancel after this 48 hour period, full cancellation fees will apply. Please contact the property direct for bookings made within 72 hours.
